Mission Statement:

To provide the finest possible fire, rescue, and emergency medical services, whether routine or emergent, to all that reside in, work in or visit the Centerville-Osterville-Marstons Mills Fire District.

The Centerville-Osterville-Marstons Mills Fire Department (COMM Fire) is a municipal fire district located in the Town of Barnstable, Cape Cod, Massachusetts, and is seeking the right candidates to join our dynamic team.

The COMM Fire District was incorporated in 1926 and serves the villages of Centerville, Osterville, and Marstons Mills. The response area is approximately 26 square miles and includes over 8 miles of ocean-front and many bays and inlets. The COMM Fire District has a year-round population of 28,000 residents and a summer population that swells to over 40,000 residents and guests. COMM Fire responds to nearly 5000 emergency calls per year.

COMM Fire operates four shifts of 12 Firefighter/EMT/Paramedics with a minimum assignment of a shift commanders and three firefighters at the Centerville (headquarters) stations, and three firefighters assigned to each station in Osterville and Marstons Mills. The Department operates four engines, one 100' aerial ladder, and two forestry vehicles. All three stations operate an Advanced Life Support Ambulance. The District also operates a 15 member dive team.

COMM Fire is recruiting candidates for the full-time position of Firefighter/Paramedic. COMM Fire offers extremely competitive salary and benefits.

**DUTIES/QUALIFICATIONS\*** 

ARTICLE XXVI - Duties of Centerville-Osterville-Marstons Mills Firefighters

#### **Section A. PRINCIPAL DUTIES:**

The principle duties of the members of the Centerville Osterville Marstons Mills Fire Department shall consist of the following:

Under direct supervision, to perform general duty firefighting work in combating and extinguishing fires, this may involve the performance of hazardous tasks under emergency situations while protecting life and property and frequently requiring strenuous physical exertion under conditions of smoke, extreme heat, gases, and cramped surroundings; and to perform related work as required. Alarm response with an assigned company to assist in combating and extinguishing fire; driving and operating equipment and appurtenances of heavy apparatus, including aerial ladder trucks, hose wagons, pumpers, rescue trucks, and similar firefighting apparatus; laying, coupling, connecting fire hose: advancing fire hose into burning buildings to direct fog or water stream, using various heavy stream appliances and extinguishers and placing, erecting, and climbing ladders, including aerial ladders. Ventilation of burning buildings; using forcible entry tools, if necessary, to open locked doors, windows, and skylights, and to chop out or break openings in roofs, floors, partitions, and ceilings. The entering of burning buildings to evaluate and rescue persons in danger, using ladders, stretchers, life nets, life guns, and life lines; administering first aid, resuscitation and performing emergency rescue, such as from drowning and extrication work such as from elevators, machinery, motor vehicles and similar accidents, the conducting of fire prevention practices and education programs to eliminate hazards and to promote public awareness of fire-rescue needs; and other related duties as prescribed by the Chief.

#### TITLE 2 - FIREFIGHTER/EMT-PARAMEDIC

#### **QUALIFICATIONS:**

- 1. As determined by the Chief and Board of Fire Commissioners.
- 2. Shall be certified to operate as an EMT-Paramedic in the State of Massachusetts
- 3. Shall be certified to operate as an EMT-Paramedic in the Cape & Islands EMS System.
- 4. Loss of said certification is grounds for dismissal.

#### **DUTIES:**

1. Responsible for duties in Article XXVI (above).

#### **GENERAL:**

1. Firefighter/Paramedics hired as a condition of employment may, after a minimum of five (5) years of service, transfer based on seniority, to a Firefighter/EMT-B position should one become available.

## TITLE VII. CITIES, TOWNS AND DISTRICTS

**CHAPTER 41.** OFFICERS AND EMPLOYEES OF CITIES, TOWNS AND DISTRICTS

#### **REGIONAL POLICE DISTRICTS**

Chapter 41: Section 101A Police officers or firefighters: tobacco smoking

Section 101A. Subsequent to January first, nineteen hundred eighty-eight, no person who smokes any tobacco product shall be eligible for appointment as a police officer or firefighter in a city or town and no person so appointed after said date shall continue in such office or position if such person thereafter smokes any tobacco products. The personnel administrator shall promulgate regulations for the implementation of this section.

Agreement Between the Centerville-Osterville-Marstons Mills Fire District and the Centerville-Osterville-Marstons Mills Professional Firefighters Local 2346, IAFF

July 1, 2024 through June 30, 2027

#### Section B. LIVING RADIUS:

- (1) Employees covered by this agreement must live within the following towns; Dennis, Yarmouth, Town of Barnstable (any village), Sandwich, Mashpee, Falmouth, Bourne, Plymouth, Wareham, Marion, Rochester, Middleboro, Carver or Plympton within thirty (30) days after notification of the end of their probationary period.
- (2) Employees that live within the COMM Fire District may respond to any station on first call.
- (3) Employees that live outside the COMM Fire District and within eight (8) miles of any station may respond for standby at those stations on first call, and to stations that are outside of eight (8) miles on or after 3rd call.
- (4) Employees who live outside the COMM Fire District but are in the District at the time of a call or standby may participate in the same according to posted response standards.
